## Disclosure Form of Relevant Financial Relationships

### By Author (s) of Poster Presentations for Poster Symposium

The intent of this disclosure is to allow Palm Beach County Medical Society (PBCMS) the opportunity to resolve any potential conflicts of interest to assure balance, independence, objectivity and scientific rigor in all of the poster presentations at. **Commercial Interest:** Any proprietary entity producing health care goods or services, with the exemption of nonprofit or government organizations and non-health care related companies.
